### General Information

Southgate Squash and Racketball Club (SSRC) is an unincorporated association owned and managed by its members through an elected Committee. It manages all activity on the courts (as an agent of WCGT) and membership fees and as an assessed club has a duty to pay an assessment fee to the WCGT for use of the Trusts facilities. Every member is obliged to consider their actions when using the facilities and do so responsibly. The rules published below are a guide and not exclusive and will be reviewed and updated on an on-going basis. A membership form must be completed in full and returned, with your payment to: The Administrator - SSRC Committee, Walker Cricket Ground, Waterfall Road, Southgate, LONDON, N14 7JZ. **Completing an application online assumes you have read, understood and agreed to abide by the rules.**

The annual membership fee includes membership of England Squash. Please indicate on the application form if you are NOT happy for your details to be shared with England Squash who may also communicate with you from time to time.

It is advisable to register an email address to enable easy communications between SSRC, other members and yourself. The online booking system will have a directory of members with telephone numbers. If, however, you do not want your details available to other members you may elect to not to share them.

If you require a family membership this is for 2 adults, married or co-habiting partners and up to 2 dependant children aged under 19 as at 1<sup>st</sup> Sept. Additional dependant children can join at the current junior rate without incurring additional admin fee. Home address and home telephone number must be the same as named lead member – correspondence will be addressed primarily to the lead member and will be by email in the first instance.

## Membership Rules

### Use of Courts

1. All members will play squash or racketball according to ES published rules and regulations.
2. All persons using courts will wear non-marking shoes on court, wear appropriate clothing and use the correct equipment.
3. Courts are to be booked for the playing of squash or racketball only and all other uses must be cleared with the Committee.
4. Members and their guests will pay the appropriate court and visitors fee, in advance.
5. Members will give 48 hours notice of cancelling a court or not expect a refund.
6. Coaches and coach use of courts is by prior approval of the Committee.
7. Visitors playing a member may only do so 3 times per year and must pay the published visitors fee and be registered in the visitors book. Any members found not playing the appropriate visitors will have their account suspended until the outstanding amount is paid.
8. Knock on court door and await acknowledgement before entering court.
9. Club Night is for members to mix in to play each other and introduce new and prospective members to the club.
10. Junior members have access to free courts by using the 'walk-up' facility that is booking a court at the last minute at the touch screen. **The walk-up facility cannot be used to book courts for any adults or visitors.** Juniors playing a junior visitor should book online when the correct fee for the court and a reduced visitor fee will be charged. If booking at the touch screen court payment and visitor fee will be deducted.

### Membership

11. Members will complete an application or registration form, in full, and advise the Committee of any changes.
12. Membership is considered continuous and members renewing after 30 days after the due date will have membership backdated or pay a fine of £10 per month not exceeding the new member's administration fee of £30.
13. Juniors of an approved standard can be invited to enter the adult leagues and competitions but **must play matches on booked courts and pay the appropriate court booking fee. Walk-up courts should not be used.**
14. Refunds will only be given pro-rata during the first 3 months after renewal date, subject to Committee approval. Thereafter the full annual fee is non refundable.
15. Court booking account: when leaving the club a member may request (within 6 months) refund of monies held in a members court booking account subject to an admin charge of £1.75. Monies not claimed will be considered a donation to the Squash Club Social Fund that supports junior squash at Southgate.
16. Membership suspension is given in extreme cases of injury, on written application and with approval by the committee. Notify the Committee, in writing, as soon as possible. NO adjustment will be made in retrospect. Maximum suspension time is 6 months.

### General

18. This is a members club and as such ALL members are responsible to see that the correct fees: for visitors, general public is collected.
19. Members are responsible for their visitors and children's behaviour.
20. Adult non - member beginners are allowed to take coaching, play club night before joining the club. But after 6 sessions expected to join.
21. Junior non-member beginners are allowed to take Saturday coaching without being a member.
22. Juniors (U19) must wear eye protection on court as recommended by England Squash. Not doing so will affect any accident liability.
23. Please keep noise on the balcony and in the corridors to a minimum.
24. Children should not be on the balcony unless accompanied by an adult.
25. Any abuse of the electronic booking system: hardware, software, lights, thermostats will result in loss of membership.
26. Members will respect the property of SSRC and the Trust. Any abuse will result in the loss of membership.
27. Members will respect the club rules and any transgressions will be result in loss of membership.
28. The SSRC notice board and Booking System forum and message board is for the use of communication to the broader membership. All notices need to be pre approved by the SSRC Committee.

30. These rules may be updated from time to time and you agree to accept any changes.
